

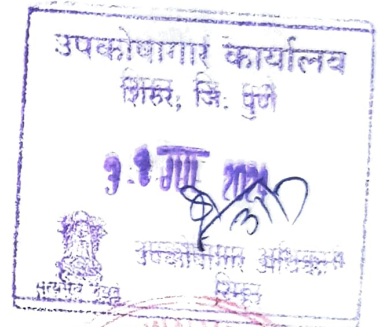

Pune do hereby solemnly affirm and sincerely state as follows:

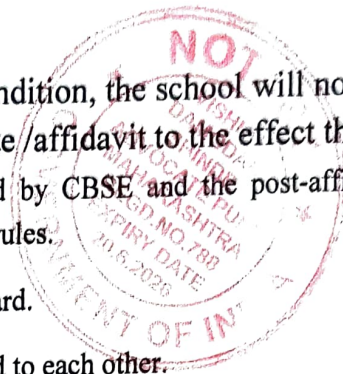
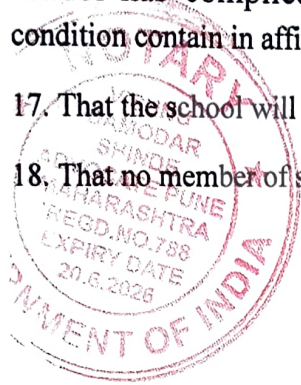
1. That **Holy Angels' convent society At post. Manjari khurd Tal. Haveli Dist. Pune** is a registered trust under the Societies registration Act.1860 and Bombay public trust Act.1950.
2. That **Holy Angels' convent society At Post. Manjari khurd Tal. Haveli Dist. Pune** is of Non Proprietary character.
3. That the school is being run as a community service and not as a business and that commercialization does not take place in the school in any manner whatsoever.
4. That no part of income from the institution being and will be diverted to any individual in the trust/society/company/school management committee or to any other person/entity. the saving if any, after meeting the recurring and non-recurring expenditure and will be further utilized for promoting the school and extending the cause of education in the same school only.
5. That school is not paying of any charges towards using name, motto, logo or any other non-academic activities to any other institution, organization or body.
6. That the school will not open classes under CBSE pattern particularly class IX/X and will not use CBSE name in any manner without obtaining affiliation.
7. That the principal and correspondent/manager of the school have individually gone through the provision contained in the affiliation & examination byelaws and the circular issued by the board from time to time. The school undertakes to abide the provision contain in the affiliation & examination byelaws, direction issued from the time to time and the law of the land.
8. That the school will ensure compliance of all statutory requirements likes EPF, ESIC and labour laws etc. with respect to the school and staff of the school.
9. That the school will ensure that the building safety, fire safety, water safety, health and hygiene certificates are being issued or renewed by the concerned multiple or state authorities from time to time as per the prescribed term.
10. That the school will ensure that all required infrastructure is available with the school before starting classes.
11. That the school will ensure that sufficient number of qualified teachers as per the provision contain in affiliation bye-laws are available with the school before starting classes.
12. That the school will follow the provision related to fee contained in affiliation bye-laws and will disclose the details of the fees to the student /parent every year before start to session without restoring to any hidden charges in the heads of the fee.
13. That the school will not coerce any student/parent to buy books/stationary/uniform from any particular shop.
14. That the school shall strive to make efforts for conservation of environment.

15. That the school will ensure that the school fulfils all essential requirement before applying for affiliation and will Fulfill all other conditions post affiliation and comply with all the generals rules as given in the affiliation byelaws or notified from time to time.

16. That in case affiliation has been with certain condition, the school will not start CBSE pattern classes without submitting a certificate/affidavit to the effect that the school has complied with all the conditions imposed by CBSE and the post-affiliation condition contain in affiliation byelaws along with generals rules.

17. That the school will not sponsors students from other board.

18. That no member of school managing committee is related to each other.

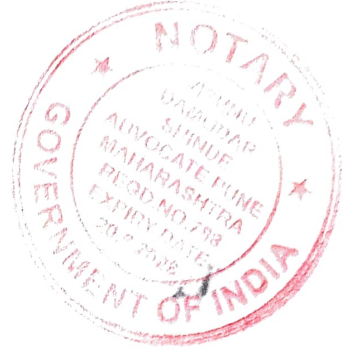
